The Committee agrees:

*The following men's events will be held: Bareback Riding, Calf Roping, Saddle Bronc Riding, Steer Wrestling, Team Roping and Bull Riding.

*The following women's events will be held: Breakaway Roping and Barrel Racing.

The NSRA agrees to:

*To publish in at least two issues of the official newsletter of the NSRA, the facts and information provided on the approval sheet.

*To sanction the said rodeo for participation by its members and to apply money won at said rodeo to the yearly event and all-around standings.

*To guarantee the payment of all checks written by its members for entry fees received from the said member at the co-approved rodeo.

The Committee agrees to hold the NSRA harmless from any and all liability incurred in the production of the described rodeo and from any and all liability, which might arise from the negligent acts of individual members.
