## Terms and Conditions for a FIRST approved NSRA Rodeo

By signing this agreement, the Rodeo Committee, hereinafter referred to as the Committee agrees, if approved, to conduct and produce a Nebraska State Rodeo Association (NSRA) sanctioned rodeo and to abide by the following agreement:

The Committee agrees:

- The following men's events will be held-bareback riding, calf roping, saddle bronc riding, steer wrestling, team roping, and bull riding. Steer Roping is an optional event.
- The following women's events will be held-ladies breakaway roping and barrel racing.
- The entry fees in all the timed events must be equal. Team roping fees will be as much **per man** as the other timed events.
- The committee will add at least \$100 per event to the purse.
- The committee will remit to the NSRA 6% entry fees.
- Each contestant will pay an office charge of \$15 of which \$8 will be remitted to the NSRA and \$7 will remain with the committee.
- No stock charge will be assessed to the contestants.
- The committee shall use the NSRA central entry system. The central entry office will take entries, draw positions, and provide the committee with day sheets and the local secretary with a complete and accurate set of books.
- The committee agrees to have banners, signs, flags, etc for any of the NSRA corporate sponsors at their rodeo.
- The committee agrees to have their local secretary collect amounts due the NSRA from contestants before said contestants are allowed to compete. A list will be provided by the NSRA.
- The committee shall be a member in good standing of the NSRA and remit to the NSRA the current year's dues.
- The committee agrees to honor all NSRA membership cards including gold cards that are presented for admittance at the gate. Any member presenting a current membership card (they are issued yearly) will be admitted without being charged. In the NSRA's opinion, there will be very little abuse from our members attending several performances because most of them are trying to make several rodeos every weekend.
- The committee agrees to provide someone to keep the area immediately around the arena gates free from spectators, particularly during the barrel race.
- All hired personnel including bullfighters, clowns, announcers, pickup men and stock contractors must be in good standing with the NSRA. Judges need to be members in good standing with the NSRA.
- All rodeos must follow the standard order of events in slack and in performances unless they have obtained permission from the NSRA Executive Board prior to callbacks. The standard order of events is as follows: barebacks, calf roping, breakaway, saddle broncs, steer wrestling, team roping, ladies barrels, and bull riding. Any disregard of this rule will result in a \$100 fine for the first offense and doubled for each additional offense of the committee, stock contractor, or both.
- The committee must notify the NSRA before April 1 if they want to add steer roping as an event to their rodeo.

The NSRA agrees:

- To publish in at least two issues of the official newsletter of the NSRA, the facts and information provided on the reverse side of approval.
- To sanction the said rodeo for participation by its members and to apply money won at said rodeo to the yearly event and all around standings.
- To guarantee the payment of all checks written by its members for entry fees received from the said member at the approved rodeo.
- NSRA will contact the committee after rodeo approval and notify them of their entry date, time, and the entry number.

The Committee agrees to hold the NSRA harmless from any and all liability incurred in the production of the described rodeo and from any and all liability, which might arise from the negligent acts of individual members.

Please accept this request for approval of our first approved NSRA rodeo as described in the above terms and conditions and on the Request for Approval Form. We agree to follow the above terms and conditions and the NSRA Rule book in order to have the NSRA sanction our rodeo.
